




### 42% of Delaware 5<sup>th</sup> graders say that they are White, 26% Black, 16% Hispanic, 17% are mixed-race or "other."






#### 51% of 5<sup>th</sup> graders say they get a free or reduced-price lunch at school.



#### 31% of 5<sup>th</sup> graders report living in a one-parent household (87% of which are headed by women), and 3% live with a grandparent with no parent in the home.






### More than one in four 5<sup>th</sup> graders has moved 3 or more times since starting Kindergarten. This is twice as likely in one-parent households.

### Let's take a look at an average Delaware child . . .





#### This is Sophia.



Sophia just started Kindergarten. She lives in our most densely populated county, one of over 5,000 Delaware girls her age, one of over 10,000 children her age.



Like half of all children born in Delaware, Sophia received WIC. Her mom, a single parent, works and takes classes at Del Tech so she can eventually better support her two girls.



Sophia has had health insurance through Medicaid and the **Delaware Healthy Children** Program, and attends day care with Purchase of Care payments. The State of Delaware has a BIG investment in her.



She is healthy, happy, smart, and secure.



Sophia cares for others, especially her active younger sister.




# Someday, Sophia will be part of an average classroom of 25 students.






4% will have ever tried cigarettes (more than a few puffs); this represents 1 student in Sophia's average 5<sup>th</sup> grade classroom of 25 students; almost one in three do not think there is great risk in smoking daily.




## 30% of 5<sup>th</sup> graders live with a parent who smokes. They are almost 7 times more likely to report having ever smoked.








#### Age at First Cigarette Use






#### How Delaware Students would get Cigarettes If They Wanted Them




#### 8th Grade, 2011 Past 30-day Tobacco Use by Area






#### 11th Grade, 2011: Past 30-day Tobacco Use by Area






#### Middle School Tobacco Use (Any Type) Trend, 2000-2012\*





#### Middle School Tobacco Use, by Race and Tobacco Type, Past 30 Days






#### High School Tobacco Use (Any Type) Trend, 2000-2012\*









#### Percent of Delaware Students who are Current Smokers and Want to Quit, by County





Delaware Middle School Students who are Current Smokers who have tried to quit or participated in a program





### Delaware Middle School Students who have smoked daily for 30 days in the Past but have not smoked in the Past 30 days





#### Delaware High School Students who are Current Smokers who have tried to quit or participated in a program





Delaware High School Students who have smoked daily for 30 days in the Past but have not smoked in the Past 30 days



## High School Students, under the age of 18, when buying cigarettes at a store in past 30 days




#### Sold or Gave Some one Cigarettes in the Past Year


 "Current Tobacco User" who Lives with Someone who Smokes

- Think Smoke from other People's Cigarettes is Harmful to them






### Middle School Students and Exposure to Smoke




#### High School Students and Exposure to Smoke






#### Perceptions of Risk among 2010 Delaware Middle School Students

#### Perceptions of Risk among 2010 Delaware High School Students






### Percent of 2010 DE Middle School Students who think Young People who Smoke have more Friends






## Percent of 2010 DE High School Students who think Young People who Smoke have more Friends





# Percent of 2011 Delaware 8<sup>th</sup> Grade Students' Opinion and Perception of Parent's Opinion of Smoking





# Percent of 2011 Delaware 11<sup>th</sup> Grade Students' Opinion and Perception of Parent's Opinion of Smoking





# Percentage of 2012 DE Middle School Students who have ever used Tobacco, by Race and Tobacco Type





These are the "big kids" Sophia now looks up to. ELAWARE




By the time Sophia reaches 11<sup>th</sup> grade, many of her original classmates are no longer in school. Those who leave are probably students with higher levels of "risk behaviors," including tobacco use.






**21% of Sophia's 11<sup>th</sup> grade classmates** will have smoked cigarettes in the past year; this represents 5 students in Sophia's 11<sup>th</sup> grade classroom of 25 students; more than 4 out of 5 now perceive great risk from smoking a pack or more per day.







#### Past 30 day Tobacco Use among 2012 Delaware Youth by Grade and Tobacco Product



#### And then there's college . . . .



- 21% of UD students have tried smoking cigarettes at some time in their lives; 13% have smoked in the past month
- 21% have tried smoking cigars; 6% smoked in the past month
- 17% are "current" tobacco users (cigarettes and/or cigars)



# UD Students who report smoking cigarettes in the past month

• 13% of White students

• 12% of Hispanic students

• 11% of Black students

# UD students who report smoking cigarettes in the past month

18% of male students

• 9% of female students

# Other sub-populations and smoking in the past 30 days:

- 13% of athletes smoked versus 12% of nonathletes (played on a sports team)
- 15% of Greeks smoked versus 12% of non-Greeks
- 18% of those diagnosed with asthma smoked versus 12% of those not diagnosed
- 28% of those diagnosed with ADD/ADHD smoked versus 11% of those not

# At UD, Cigars are smoked in the past month by

• 7% of White students, 4% of Hispanic students, and 2% of Black students

2% of female students and 14% of male students

Of those students who reported smoking cigarettes in the past month:

- 19% of students who smoked said they smoked only one day out of the last 30
- 73% of students say they smoked on less than half of the last 30 days
- 11% of students who smoked said they smoked on 30 of the past 30 days



Among UD students who did not smoke cigarettes in the past month, 75% drank alcohol in the past month, 54% binged.

Among those who did smoke cigarettes in the past month, 94% drank alcohol in the same time period, and 86% binged.






Among UD students who did not drink alcohol in the past month, 3% smoked cigarettes in the past month.

Among those who did drink alcohol in the past month, 15% smoked cigarettes in the same time period.

55% of students who smoked cigarettes in the past month also smoked marijuana. 41% of students who smoked marijuana in the past month also smoked cigarettes.



#### Also,

33% of students who smoked cigarettes in the past month have used illegal drugs other than marijuana, compared to only 6% of students who have not smoked cigarettes in the past month have.
